### **EXPEDITING YOUR REQUEST OR CONCERN**

Management would like to make sure all homeowners have key tips in order to expedite your maintenance request, concern or emergency:

- Please put your request in writing via email whenever possible.
- Email photos when possible. Photos enable us to get a clear picture of the location and extent of the issue needing to be addressed.
- Please indicate your Association "Northstar Ranch" in the subject line, and remember to include your full address in the body of the email for reference.
- Provide us with your best contact phone number if the issue is complex, and requires special attention.
- Please report issues as soon as you see them.
- True emergencies will always be treated as such, and will be prioritized. If there is an emergency after hours, please contact the after hours emergency service line.

### PICK-UP AFTER YOUR PET

Please pick up after your pet. This is a concern in the neighborhood where pet owners are not picking up after their pet. Doggie bag dispensers and trash receptacles are placed throughout the community. Please do not throw the doggie bags on the ground or store in front of your front door or in the bushes. This is unsightly and unhealthy. Failure to pick up after your pet will result in disciplinary fines.

### **COMPLIANCE LETTERS**

When you receive courtesy letters to call your attention to a certain compliance issue, please make sure you call Management to inform us that you are addressing the issue and/or need more time to resolve the matter. This way, we avoid pursuing further compliance action. Please remember, Management is here to help the homeowners and to try and keep Northstar Ranch looking as nice as possible.
